2. Rationale for the module and its links with other modules
Students will design and create a quilted blanket for a child.

3. Aims of the module
During this unit, students will design and make a child-centred quilted blanket combining two fabrics. They may choose what size of blanket they make and for what purpose. They will embellish, using and developing previously learned decorative techniques, and they will also explore quilting.

6. Learning, teaching and assessment strategy for the module
Teacher-led PowerPoints containing instructions, images and videos will be discussed at the beginning of each session. Each week, students are guided through a different task, including embellishment, the construction of a blanket, and quilting. They are also reminded of embellishment techniques learned over the previous two years to enable them to realise their design. Assessment is formative throughout, and a summative assessment is carried out in week 7.



7. Intended learning outcomes

At the end of the module, learners will be expected to:

1. Demonstrate and reflect on safe practice while using sewing tools and equipment and a sewing environment.
2. Calculate, mark onto fabric and cut accurate pieces.
3. Apply prior knowledge of fabric grain and cut fabric correctly and accurately for the project using appropriate tools.
4. Embellish fabric according to chosen design.
5. Assemble blanket correctly including use of topstitching and quilting.
6. Use an iron to enhance finish.

8. Indicative content (this should provide an overview of content over the number of weeks of module delivery)

Students will design, cut and construct a child's blanket. Students can choose to either make a quillow, blanket, minimum size 70cm by 90cm, to a size and shape of their choice. Decoration will be applied using skills learned throughout the course, and blankets will be quilted with a chosen motif.

Week 1: Draft measurements onto fabric and cut out

Weeks 2 and 3: Embellishment of blanket

Week 4: Construction of blanket

Week 5: Top-stitching and quilting blanket

Week 6: Top-stitching and quilting blanket

Week 7: Summative assessment

Students will carry out the project over six weeks. During that time, the lecturers will be formatively assessing the work and giving constructive feedback. In week 7, we will be carrying out summative assessment of the work produced.
